**JOINT INTERMINISTERIAL DECISION AC/2023/3704/ MT/MEF/SGG
REGARDING THE PRICING OF THE ELECTRONIC CARGO TRACKING
NOTE IN THE REPUBLIC OF GUINEA**

THE MINISTERS,

DECIDE:

Article 1:

The application of the Electronic Cargo Tracking Note (ECTN) introduced in the Republic of Guinea by Decree D/L 74/PRG/CNDD/2010 dated 29 July 2010 is subject to a single levy fixed as follows:

The applicable import tariffs are:

CTN 20'	65 EUR
CTN 40'	95 EUR
Other NTCs	65 EUR

Roro < 5 T	65 EUR
Roro > 5 T	95 EUR
Conventional bulk	0,50 Eur / T
Issuing costs	100 Eur / BL
Goods in Sub-Regional Transit Destined in Guinea	Applicable Containers Vehicles, bulk and conventional prices hereabove
Empty container	Free
Rice sugar flour, oil Vegetable, phytosanitary, fertilizers and seeds, hydrocarbons	Basic necessities are exempt

The applicable Export Rates are :

CTN 40'	95 EUR
Other NTCs	65 EUR
Roro < 5 T	65 EUR
Roro > 5 T	95 EUR
Issuing costs	Eur 100 / BL

Empty container	Free

Article 2:

Import ECTN will be paid to the mandatory on an account specifically opened for this purpose. The State reserves the right to inspect this account and the **Mandatory accepts** to provide statements of such account for reconciliations from time to time upon request by Principals.

The State's share will be paid monthly into the Guinean Shippers' Council (CGC) ECTN account opened at the Central Bank of the Republic of Guinea.

Delivery export Electronic Cargo Tracking Note (ECTN) costs will be paid in full to the CGC on its ECTN account domiciled at the Central Bank of the Republic of Guinea.

The agent's share will be paid monthly within the eighth day of the month.

Article 3: The present decision takes effect from the date of its signature, voids and replaces any previous regulation, and shall be registered and published on the Official Gazette of the Republic.
